

RESOLUTION NO. 2014-07

A RESOLUTION AMENDING PRICE CITY ' S ELECTRIC RATE SCHEDULE, AS ESTABLISHED BY RESOLUTION NO. 2013-09, BY INCREASING USAGE AND DEMAND RATES SET FORTH IN EACH RATE TABLE BY 4.5%

WHEREAS, Section 13.16.020 of the Price Municipal Code, 1988, specifically provides, in part, that electric rates shall be determined by the Price City Council; and

WHEREAS, Price City remains committed to maintaining a competitive electric rate schedule for the benefit of its customers; and

WHEREAS, Price City previously adopted an Electric Rate Schedule, as set forth in Resolution No. 2013-09, dated April 10, 2013, hereinafter referred to as the "Previous Rate Schedule"; and

WHEREAS, the cost of electrical power purchased by Price City from Rocky Mountain Power has increased and Price City is desirous of amending the Previous Rate Schedule to reflect the increase in cost incurred by Price City; and

NOW, THEREFORE, be it hereby resolved by the Price City Council as follows:

Section 1. Amendment of Certain Rate Tables: Electric Rate Table Nos. 101, 104, 105, 107, 108, 112 and 981-988 contained in the Previous Electric Rate Schedule are hereby amended to include an increase of the usage and demand rates contained therein by 4.5% as set forth in "Price City Electric Rate Schedule, as of March 12, 2014", which is attached hereto and by this reference is made a part hereof.

Section 2. Repealer. The provisions of other resolutions or other policies and procedures in conflict with the text of this resolution are hereby repealed and Resolution No. 2013-09 is hereby specifically repealed.

Section 4. Severability. The provisions of this resolution and the provisions adopted or incorporated by reference are severable.

AS OF March 12, 2014

RATE TABLE NO. 101 - RESIDENTIAL SERVICES

AVAILABILITY:

At any point on Price City's interconnected system where facilities of adequate capacity exist.

APPLICATION:

This Rate Table is for alternating current service supplied at approximately 120 or 240 volts through one kilowatt-hour meter at a single point of delivery for all service required on the premises for residential purposes.

RATE TABLE NO. 104 - GENERAL SERVICE - SMALL BUSINESS

AVAILABILITY:

At any point on Price City's interconnected system where facilities of adequate capacity exist.

APPLICATION:

This Rate Table is for alternating current, single, or three-phase non-residential electric service supplied at Price City's available voltage, but less than 46,000 volts through a single point of delivery, for all service required on the customer's premises by customers with a power requirement not greater than 30 kW during 7 of a continuous 12 month period and never exceeding 35 kW. Customers subject to this rate who fail to qualify under the above conditions shall be classified under Rate Table No. 105 for not less than 12 months.

The kW as shown by or computed from the readings of Price City's power meter for the 15-minute period of customer's greatest use during the month.

RATE TABLE NO. 105 - GENERAL SERVICE - LARGE BUSINESS

AVAILABILITY:

At any point on Price City's interconnected system where facilities of adequate capacity exist.

APPLICATION:

This Rate Table is for alternating current, single, or three-phase service supplied at Price City's available voltage, but less than 46,000 volts through a single point of delivery, for all service required on the customer's premises. This Rate Table is for general non-residential service. Customers whose power requirement is not greater than 30kW during 7 months of a continuous 12 month period and never exceeding 35 kW shall be classified under Rate Table No. 104 for not less than 12 months.

RATE TABLE NO. 107 - SPECIAL SERVICE - NON-PROFIT CHARITABLE ORGANIZATION

AVAILABILITY:

At any point on Price City's interconnected system where facilities of adequate capacity exist.

APPLICATION:

For purposes of this Rate Table, a non-profit charitable organization shall be defined as an organization or person who has received tax-exempt status from the Internal Revenue Service and which organization does not have the power to levy any tax and which organization does not receive any tax revenues from any other entity for its operation.

This Rate Table is for alternating current, single or three-phase non-residential electric service supplied at Price City's available voltage, but less than 46,000 volts through a single point of delivery. Customers subject to this rate who fail to qualify under the above conditions shall be reclassified under appropriate rate table for not less than 12 months.

At any point on Price City's interconnected system where facilities of adequate capacity exist.

APPLICATION:

For purposes of this Rate Table, a non-profit charitable organization shall be defined as an organization or person who has received tax-exempt status from the Internal Revenue Service and which organization does not have the power to levy any tax and which organization does not receive any tax revenues from any other entity for its operation.

This Rate Table is for alternating current, single or three-phase non-residential electric service supplied at Price City's available voltage, but less than 46,000 volts through a single point of delivery. Customers subject to this rate who fail to qualify under the above conditions shall be reclassified under appropriate rate table for not less than 12 months.

AVAILABILITY:

At any point on Price City's interconnected system where facilities of adequate capacity exist.

APPLICATION:

This Rate Table is for alternating current, single, or three-phase electric service supplied at Price City's available voltage, but less than 46,000 volts through a single point of delivery, for all service required on the customer's premises. Customers subject to this rate who fail to qualify shall be classified under Rate Table 105 - General Service - Large Business.

RATE TABLE NOS. 981-988 - SECURITY AREA LIGHTING

AVAILABILITY:

At any point on Price City's interconnected system. No new mercury vapor lamps or 200 watt, 22,000 lumen sodium vapor lamps will be installed after July 1, 1998.

APPLICATION:

This Rate Table is for electric service required for security area lighting and for security flood lighting service where service is supplied from an overhead pole system owned by Price City.

MONTHLY BILL:

Minimum (#981-983, 987):	\$ 22.40	Less than 250 watts
Minimum (#984-986, 988):	\$ 30.05	250 watts and up
