#### 1. PLEDGE OF ALLEGIANCE

b. UPPER PRICE RIVER WATERSHED PLAN EIS CONSULTANT CONTRACT AMENDMENT. Consideration and possible approval to amend the existing contract with Horrocks Engineers to provide for the expansion of the Plan-EIS to include the piping of approximately 50 miles of existing irrigation canals. Amendment to include \$964,318.00 of additional cost and an extension of 24 months beyond the original contract.

Consideration and possible approval of an agreement with the State Division of Water Resources to receive up to \$5000.00 in matching funds to purchase smart sprinkler controllers to be utilized in the City's Parks, Cemeteries and other landscaped properties.

e. ELECTRIC VEHICLE CHARGING STATION. Consideration and possible approval of documents and actions and related matters necessary for the acquisition and operation of the 100 E 100 N EV charging units by Price City.

f. 2023 UTAH MAIN STREET PROGRAM TIER 2 MOU. Consideration and possible approval for Memorandum of Understanding between Price Main Street Program and Utah Main Street Program.

g. BUS DONATION. Consideration and possible approval of acceptance of donated bus from SEUALG to Price City.
