

MINUTES OF PRICE CITY COUNCIL MEETING
MEETING HELD ON OCTOBER 27, 2010, 5:00 p.m.

The Price City Council meeting convened in regular session on October 27, 2010, in the Price City Hall Council Chambers, Room 104 at 5 p.m.

MOTION. Councilmember Hanna-Smith moved to open the public hearing at 5 p.m. Motion seconded by Councilmember Tatton.

COMMUNITY DEVELOPMENT BLOCK GRANT PUBLIC HEARING:

Mayor Joe L. Piccolo, opened the public hearing at 5 p.m. for the Community Development Block Grant (CDBG) program and stated that this hearing is being called to consider potential projects for which funding may be applied under the 2011 CDBG Program. Nick Tatton explained that the grant money must be spent on projects benefiting primarily low and moderate-income persons. The Southeastern Utah Association of Local Governments Region, of which Price City is a member, is expecting to receive approximately \$400,000 in this new program year. All eligible activities that can be accomplished under this program are identified in the CDBG Application Guide and interested persons can review it at any time. Mayor Piccolo read several of the eligible activities listed such as: construction of public works and facilities, i.e.: water and sewer lines, fire stations, acquisition of real property, provision of public services such as food banks or homeless shelters. Also eligible are loan programs for private businesses which would then hire low income persons and the program can also pay for housing rehabilitation for low income homeowners or for persons owning rental housing for lower income persons. Mayor Piccolo indicated that in the past the City has received CDBG funds for ADA access projects and pedestrian pathways (sidewalks) leading to income targeted housing, income targeted housing projects and recreation projects in the past. The City has handed out its capital investment plan as part of the regional "Consolidated Plan". This list shows which projects Price City has identified as being needed in the community. It was asked that anyone with questions, comments or suggestions during the hearing please identify themselves by name, before they speak. A project to facilitate funding for improvements to the Community Nursing Services building was presented by Lynn Desmond from Community Nursing Services. Mayor Piccolo then opened the meeting up to further suggestions from the audience. No further suggestions or responses were provided. The hearing as adjourned at 5:12 p.m. **MOTION**. Councilmember Tatton moved to close the public hearing. Motion seconded by Councilmember McEvoy.
